## **BOARD OF DIRECTORS' ACTIONS**

The meeting was passed to our new chairman, Bev Wendell.

Minutes of the meeting of May 15, 2005 read and a motion to accept the minutes as read was made by Randy Neatherlin and seconded by Jim Clark, motion passed by unanimous voice vote.

### **Treasurer's Report**

Bev Wendell gave us his last treasurer's report. We took in \$60 in dues and \$109 in donations for a total of \$679.73 in the bank.

A motion to accept the treasurer's report as read made by Judy Scott, second by Lee Swoboda and passes unanimous by voice vote.

A motion to remove Lee Swoboda and install Jim Clark on the bank check writing card was made by Randy Neatherlin, second by Mike Greene and passed unanimously.

### **Health Care Forum**

A motion to have the letter sent to Bev Wendell for final approval before sending it on, made by Randy Neatherlin, second by Mike Greene and passed by voice vote unanimous.

It was discussed of having a facilitator when we discuss issues between the Hospital Board and our Health Care Committee.

The Health Care Forum is a plan to deliver and improve health care in the North Mason area and is a planning process that is ongoing.

A discussion followed on Shelton and Fire District #5 combining to save money and duplication of services. There are 17 Fire Districts in Mason County.

## **NEW BUSINESS**

A motion to have a Community Candidates Forum on a Saturday in August that does not interfere with other events made by Randy Neatherlin, second by Jim Clark and passed unanimously by voice vote.

A motion for the mechanics of the Candidates Forum to be decided by committee made by Lee Swoboda and second by Mike Greene, passes unanimously.

A discussion on the Belfair incorporation proposal followed. We need objections and questions to be answered on this issue to gather information.

Bev Wendell appointed Mike Greene to head this committee.

The School Bond issue was discussed and it was decided we should attend School Board Meetings to give our input as individuals, not members of the North Mason Community Voice.

A motion to adjourn by Judy Scott, second by Jim Clark and passed unanimous by voice vote.
